I ACCEPT RESONSBILITY FOR ENSURING ALL MATERIALS PROVIDED HAVE SUBMIT TED AND VALID FBC APPROVED (NOA'S) AND WILL BE INSTALLED ACCORDING TO MANUFACTURERS SPECIFICATION AND CURRENT FBC STANDARDS, INCLUSIVE OF ROOF SHEATHING FASTENING SPACING REQUIREMENTS.

I UNDERSTAND A LADDER THAT EXTENDS A MINIMUM OF 3 FEET ABOVE THE ROOF LINE MUST BE SUPPLIED AT TIME OF INSPECTION. PERMITS MUST BE CLEARLY POSTED ON PREMISES AND ALL DUMPSTERS AND ROOFING DEBRIS MUST BE REMOVED PRIOR TO FINAL INSPECTION. I UNDERSTAND THAT ONLY WITH COMPLETION OF AN OWNER'S ACKNOWLEDGEMENT BELOW AM I ABLE TO FOREGO AN IN-PROGRESS ROOF SHEATHING INSPECTION , MAKING ME RESPONSIBLE FOR ASSURING ALL ROOF SHEATHING FASTENING REQUIREMENTS MEET CURRENT FBC STANDARDS PRIOR TO COVERING.

THE FOLLOWING APPROVED INSPECTIONS ARE REQUIRED IN ORDER TO COMPLETE THIS PERMIT:

- . **UNDERLAYMENT AND OR ROOF METAL, TIN-TAG AND DRIP EDGE REQUIRE INSPECTION.**
- . **ANY ADDITIONAL ROOF FRAMING, BATTENS, PURLINS REQUIRE IN-PROGRESS INSPECTION.**
- . **FINAL INSPECTION**
