CODE ENFORCEMENT SPECIAL MAGISTRATE HEARING AGENT AUTHORIZATION FORM

Failure to provide such form shall prevent your agent from appearing and speaking on your behalf. **EACH PROPERTY OWNER FOR A PROPERTY MUST COMPLETE A SEPARATE AGENT AUTHORIZATION FORM TO ALLOW THE AGENT TO ACT UPON HIS/HER/ITS BEHALF. AN AGENT AUTHORIZATION FORM IS NOT REQUIRED FOR ATTORNEYS REPRESENTING THE PROPERTY OWNER, OR FOR MANAGING MEMBERS, OFFICERS, OR DIRECTORS (AS CONFIRMED BY SUNBIZ) FOR PROPERTIES OWNED BY A COMPANY.**
