#### GARAGE SALE RULES & REGULATIONS

## Regulations

- 1. A ten dollar (\$10.00) non-refundable administrative processing fee shall be made payable to the Village of Royal Palm Beach.
- 2. Only three (3) garage sale permits per residential premises shall be issued in a twelve-month (12) period (one (1) garage sale approximately every four (4) months.
- 3. A garage sale permit shall permit the applicant to conduct a garage sale for three (3) consecutive days.
- 4. You may reschedule a garage sale one (1) time. In order to reschedule your garage sale, you must call the Code Enforcement number at 790-5138 the first (1<sup>st</sup>) day of the sale by 9:00 am. Garage Sales must be rescheduled within 30 days of the original garage sale permit.

# Signs (Section 20.25.13)

- 1. Garage Sale signs, limited to one (1) sign per road frontage at sale site, with a maximum of three (3) off-site signs to be placed in the village road rights-of-way, total of three (3) signs.
- 2. Signs may not exceed four (4) square feet in size.
- 3. Garage Sale signs stating location and date of sale are allowed for a maximum period of seventy-two (72) hours or three (3) days.
- 4. Off-site signs may be fastened to a wood stake installed in the ground no higher than four (4) feet above ground level.
- 5. Signs are only allowed on Village road right-of-ways. Signs are not allowed on Okeechobee Blvd., State Road 7, Southern Blvd, or Belvedere Road (east of SR7).
- 6. Off-site signs may not be attached to traffic signs, poles, fire hydrants, etc and are prohibited on county, state, and federal road right-of-ways.
- 7. Signs must be removed and discarded at the end of sale by the customer.
- 8. Code Enforcement Officers will remove illegal signs on roadways, or off property of sale. Three (3) Village approved signs will be provided at time of application (these are the only signs permitted for off-site use).
