Other Covered Benefits for Employees of the Village of Royal Palm Beach

Health Reimbursement Account (HRA) – The Village of Royal Palm Beach provides a Health Reimbursement Account (HRA) for employees who reach age 65 or older within the 2021-2022 plan year and are covered under the Village's HDHP Open Access Plus Plan. Employees enrolled in the HDHP plan are automatically enrolled in the Health Reimbursement Account at no additional charge. Employees enrolled in the HDHP plan will receive \$2,000 per plan year for single coverage or \$4,000 per plan year for family coverage. HRA monies are funded by the Village and can be used for any qualified medical expense that is incurred under the medical plan such as deductibles and coinsurance for physician services, hospital services, prescription drugs, and other qualified medical services. The HRA monies will roll forward. However, if the participant discontinues participation or separates from the Village funds are available for one (1) year.

Coverage for: 10/01/2021 to 09/30/2022

How does it work? — When employee incurs an eligible expense, employee can pay the charge with the HRA debit card instead of paying out of pocket and submitting for reimbursement. Employee can utilize the debit card at health care providers and pharmacies that are providers of qualified medical services and accept debit cards for payment.

If employee's provider or merchant does not accept MasterCard debit cards or employee chooses not to use it, employee will need to pay for expenses incurred and may submit a request for reimbursement. When submitting reimbursement form, make sure to include the appropriate documentation such as an Explanation of Benefits (EOB) and receipt of payment for the services rendered.
