Please transfer \$582,421.00 from the 302 Fund Balance to Project No. PR2307, Veterans Park Splash Pad Design Rebuild, Account No.302-7200-572.63-80.

The requested amount will provide funding to fully award the project and provide a 5% contingency.

The additional funding is required due to a change in the scope of work and the escalation in material and labor prices. The scope change was required due to unforeseen conditions that were discovered during the design process. Tree roots have damaged the piping between the splash pad and the equipment vaults and it will need to be completely re-routed and replaced. The equipment and vaults are over twenty years old, we have elected to replace them as part of the repairs in order to insure we have a fully function system after the repairs are completed. This project was advertised for RFP's three times and we have received a single bid.
