**Agenda Item:**

**PUBLIC HEARING TO CONSIDER APPLICATION NO. 24-021 (AAR), AN APPLICATION BY PIERCE HAGGARD ON BEHALF OF R. P. LOGISTICS, LLC. THE APPLICANT IS SEEKING ARCHITECTURAL APPROVAL TO CHANGE THE FINISH OF THE APPROVED ART IN PUBLIC PLACES SCULPTURE FROM A POLISHED STAINLESS STEEL FINISH TO A METALLIC PAINT FINISH, FOR A PROPERTY LOCATED AT 100 ALDI WAY.**

**Issue:**

The Applicant is requesting Architectural Approval to change the approved sculpture’s finish from polished stainless steel to Sherwin Williams DTM Wash Primer and KEM 4000 Silver Metallic Top Coat paint for an on-site, installed 10’ high by 8’ wide by 8’ deep sculpture titled “Transcendence” created by local artist Robert Fehre. The sculpture was installed as the approved form but with ***a painted finish***. The applicant is requesting that the current paint finish be approved instead of the previously approved polished stainless steel. “Transcendence” is a large-scale, place-making landmark sculpture that was fabricated with welded stainless steel. The uplifting sculpture aims to relay the message of “moving forward” in life as well as the progression of life and challenges we all face.”

Please refer to **Attachments A, B, and C** for illustrations of the sculpture installed on site, the details of the primer and paint colors, and the location of the sculpture.

The Public Art Advisory Board considered this application on May 28, 2024 and recommended Approval by a vote of 5-0.

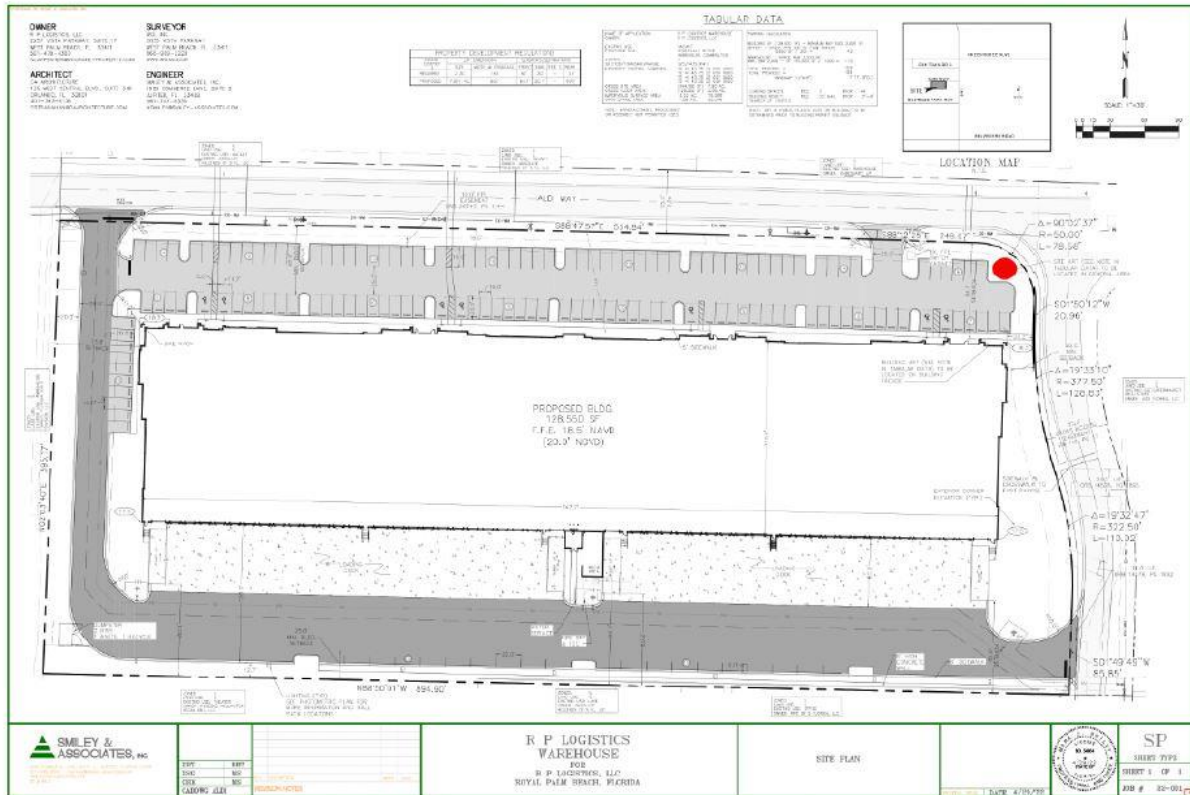

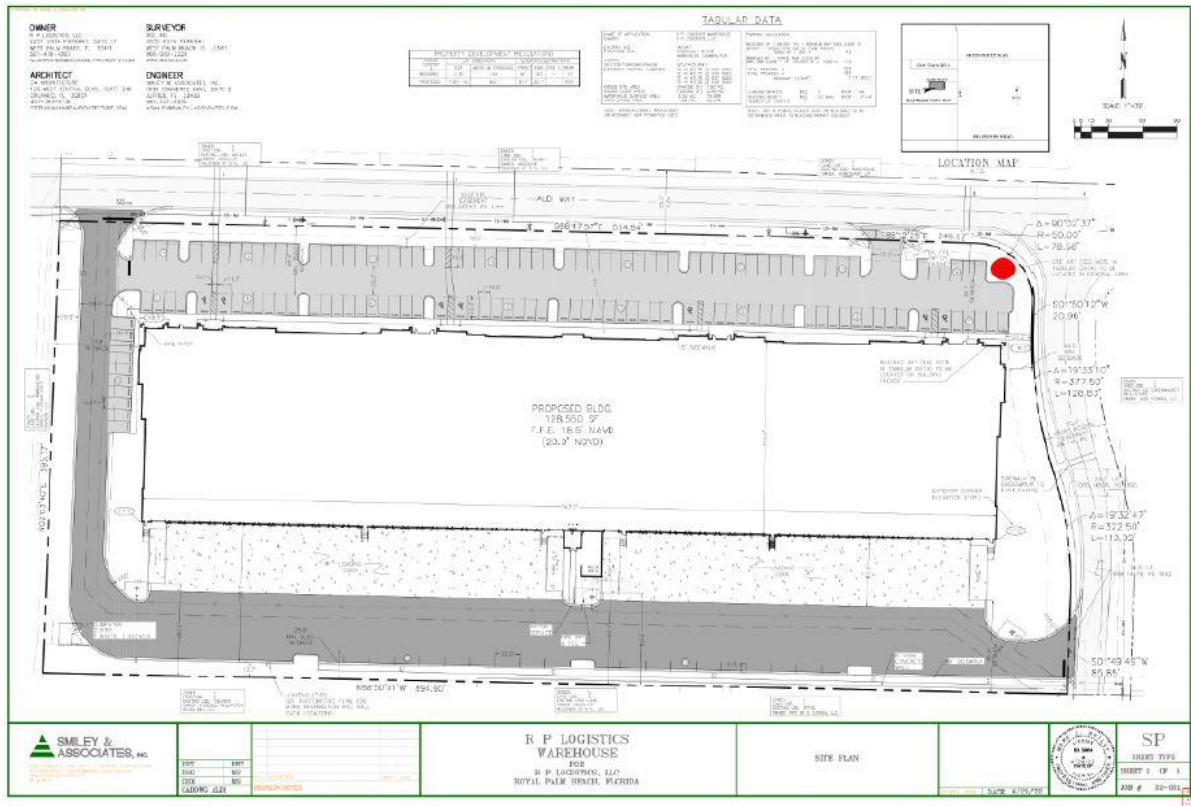
