Agenda Item #: C - 5

Agenda Item: Approval for the Mayor to execute a "Consent to Assignment of Website Design Implementation and Hosting Agreement" in order to assign the current Agreement with Municipal Code Corporation to CivicPlus, LLC.

The Village solicited a request for proposals on July 6, 2018 for the design and ongoing hosting and support of Village's website. After review of proposers' qualification, technical approach, implementation and ongoing hosting and support costs, the Selection Committee recommended awarding the contract to Municipal Code Corporation ("Municode") as they were the lowest responsive, responsible proposer. On September 20, 2018, the Village and Municode entered into a Website Design Implementation and Hosting Agreement ("Agreement")

In June 2022, CivicPlus LLC announced the acquisition of Municode and notified the Village that it had become the billing entity and payee for annual website hosting and support services. Section 16 of the Agreement provides that the Village must give written consent to any assignment of the Agreement.

Recommended Action:

Staff recommends approval of the Consent to Assignment, retroactively as of June 30, 2022.
