## AGENDA ITEM:

Adoption of Resolution No. 25-09, A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, APPROVING AN APPLICATION TO THE TRANSPORTATION ALTERNATIVES GRANT PROGRAM THROUGH THE PALM BEACH TRANSPORTATION PLANNING AGENCY FOR THE IMPROVEMENT OF SIDEWALKS ALONG OKEECHOBEE BOULEVARD, THE FPL PATHWAY, SPARROW DRIVE, AND LAMSTEIN LANE TO ALLOW FOR CONVENIENT, SAFE, AND ADA-COMPLIANT PEDESTRAIN AND BICYCLE TRAVEL, AND COMMITTING TO FUND ONGOING OPERATIONS AND MAINTENANCE THROUGH THE USEFUL LIFE OF THE PROJECT; AUTHORIZING THE MAYOR OR VILLAGE MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

### ISSUE:

The Village is submitting an application to the Palm Beach Transportation Planning Agency for the 2024 Transportation Alternatives Grant Program for the Capital Project, EN2305 FPL Ped & Bike Improvements. The requested grant funding will be approximately \$550,000, and the Village will be funding approximately \$100,000. The project proposes to improve of sidewalks along Okeechobee Blvd, The FPL Pathway, Sparrow Drive & Lamstein Lane to allow for convenient, safe & ADA Compliant Pedestrian & Bicycle travel. While committing to fund ongoing operations & maintenance through the useful life of the project.

**WHEREAS**, it is incumbent upon community leaders to ensure the safety and welfare of residents and visitors in Royal Palm Beach; and

**WHEREAS**, the Village of Royal Palm Beach wishes to construct or modify sidewalks through the Village to meet current Americans with Disabilities Act ("ADA") Standards and apply for funding related to the system, and apply for funding related to the network.

# NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, THAT:

**Section 1.** The Village Council hereby approves the Village's application for Transportation Alternatives Grant Program funding for EN2305 FPL Ped & Bike Improvements to support the Village's continued efforts for safety and aesthetics on Village roadways.

**Section 2.** The Village Council hereby authorizes the Mayor or Village Manager to do all that is necessary to make application for this Transportation Alternatives Grant Program funding through the Palm Beach County Transportation Planning Agency.

**Section 3.** This Resolution shall become effective immediately upon adoption.
