AGENDA ITEM:

Approval and authorization for the Village Manager to execute the First Addendum to Agreement for Professional Municipal Engineering Services to extend the term with Erdman Anthony for the first two-year renewal period.

On October 1, 2023, the Village Council entered into an Agreement for Professional Municipal Engineering Services with Erdman Anthony. The original Agreement allowed for two (2) additional two-year extensions upon the mutual agreement of the parties.

FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL MUNICIPAL ENGINEERING SERVICES

THIS FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL MUNICIPAL ENGINEERING SERVICES ("First Addendum"), made and entered into this _____ day of August, 2025, effective October 1, 2025, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the "Village", and Erdman Anthony of Florida, Inc., with principal address at 145 Culver Road, Suite 200, Rochester NY 14620 hereinafter referred to as "Consultant", both of whom agree that the current "Agreement for Professional Municipal Engineering Services" made and entered into by the Village and Consultant effective October 1, 2023, is hereby amended in the following manner:

Section 1: The above-referenced Agreement is hereby extended for the first of two (2) available two-year renewal periods commencing October 1, 2025 and ending on September 30, 2027 at the rates set forth in Exhibit "A" attached hereto and incorporated herein by reference. This first extension of the term is permitted by and in accordance with Article 1 of the Agreement.

Section 2: This First Addendum shall be attached to the current Agreement and shall become a part thereof.
