### **AGENDA ITEM:**

# **Background:**

This project involves the milling & resurfacing of multiple approximately 58 lane miles of residential & collector roads throughout the Village. It will include striping, ADA curb ramp improvements, road base repair & drainage structure modification. This project was added to the Capital Improvement Program in 2022 and was ranked as a "High Priority" in the Strategic Plan under "Targets for Action" 2024/2025.
