# **RESOLUTION NO. 25-18**

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, SUPPORTING THE RENAMING OF A PORTION OF CRESTWOOD BOULEVARD SOUTH OF OKEECHOBEE BOULEVARD TO COCOPLUM LANE TO VERDENIA C. BAKER BOULEVARD; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

**WHEREAS,** Verdenia C. Baker rose through the ranks of Palm Beach County government ascending to the position of County Administrator in 2015; and

**WHEREAS,** during her lengthy tenure, Ms. Baker dedicated herself and her career to improving the quality of life for residents and business owners in, and visitors to, Palm Beach Couty, with a particular focus on housing, tourism and economic development; and

**WHEREAS,** Ms. Baker is held in high regard and is deeply respected and admired not only by her political colleagues but also by leaders and members of national, state, local, professional, and community organizations; and

**WHEREAS,** Verdenia C. Baker has long served as an example and a role model for women in government by using her intelligence and experience to achieve the highest nonelected position in Palm Beach County government; and

**WHEREAS,** the Village Council of the Village of Royal Palm Beach supports the renaming of a section of Crestwood Boulevard within the Village of Royal Palm Beach to honor the public service of Verdenia C. Baker.

# NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, THAT:

<u>Section 1:</u> The Village Council hereby supports and encourages Palm Beach County to rename the portion of Crestwood Boulevard south of Okeechobee Boulevard to Cocoplum Lane to Verdenia C. Baker Boulevard.
