- 1. The event may take place on Friday, October 3, 2025 from 5:00 p.m. until 10:00 p.m.; and Saturday, October 4, 2025 from 3:00 p.m. until 9:00 p.m. at Royal Palm Beach Commons.
- 2. Any tents used shall be flame resistant.
- 3. All electrical circuits shall be GFI protected.
- 4. A clearly defined parking area must be provided.
- 5. The applicant shall provide for portable restroom facilities including at least one handicapped accessible facility if public facilities are not within 500' of accessibility.
- 6. Adequate trash receptacles shall be provided for debris, which may accumulate on site.
