#### Agenda Item:

PUBLIC HEARING TO CONSIDER APPLICATION NO. 25-057 (AAR), AN APPLICATION BY INSITE STUDIO, ON BEHALF OF FLORIDA SOUTH DIVISION, LLC. THE APPLICANT IS REQUESTING ARCHITECTURAL & AESTHETIC APPROVAL FOR THE PURCHASE AND INSTALLATION OF THREE (3) PEDESTAL RING SCULPTURES RANGING FROM FOUR (4) FEET TO (6) FEET IN DIAMETER AND UP TO 13 FEET TALL TITLED "COLORFUL PERSPECTIVES" BY ARTIST LUCY KESHAVARZ IN ORDER TO FULFILL THE ART IN PUBLIC PLACES REQUIREMENT, FOR A PROPERTY LOCATED AT 1171 N. STATE ROAD 7.

#### ISSUE:

The Applicant is requesting Architectural & Aesthetic Approval for the purchase and installation of three (3) pedestal ring sculptures ranging from four (4) feet to (6) feet in diameter and up to 13 feet tall (excluding base) titled "Colorful Perspectives" by artist Lucy Keshavarz in order to fulfill the Art in Public Places requirement. Please refer to the Applicant's Justification Statement for details regarding lighting and materials of the proposed sculpture.

The certified cost estimates for the project were stated as \$19,520,000 triggering the Village's Art in Public Places requirement for any private development whose one percent (1%) of total vertical construction costs is over \$25,000.00. The one percent (1%) amount required Art in Public Places installation for the Aldi Distribution Public Art project is \$195,200.00.

The estimated amount to complete the commission and installation of the stainless steel sculptures titled "Colorful Perspectives" by artist Lucy Keshavarz is estimated at \$195,500.00. This project fulfills the Art in Public Places requirement outlined in Sec. 26-75.5. – Art in Public Places under the Village's Code of Ordinances.

The Village's Public Art Advisory Board considered the application on August 26, 2025, and recommended Approval by a vote of 5-0.



since the applicant meets the review criteria set forth in Section 26-75.5(g) of the Village Code of Ordinances.


