Subject: Budget Amendment Request – Antenna Replacement & Repeater Relocate

Purpose:

This memo serves to request a budget amendment to allocate an additional \$7,500 to project EN2401 for the purpose of relocating and replacing radio tower equipment.

Background:

The current radio tower equipment is housed at the PBSO District 9 Station where the cable ingress has inadvertently created a pathway for rodent infestation. This has led to unsanitary conditions and operational concerns within the facility. Additionally, the decentralized location of the equipment has posed logistical challenges for maintenance and oversight.

Justification:

This relocation is an unplanned but necessary event prompted by two critical factors:

1. Health and Safety Concerns:

The cable ingress has become a conduit for rats entering the Police Station, compromising the health and safety of personnel and the integrity of the facility.

2. Operational Efficiency:

Moving the equipment to a centralized location on village-owned property will improve access, streamline maintenance, and enhance system reliability.

Budget Impact:

An additional \$7,500 is required to cover the costs associated with:

- Decommissioning and removal of existing antennas and cable on tower.
- Procurement and installation of replacement components
- Removal of repeaters from PBSO Infrastructure and migration to DBF
- Labor and incidental expenses related to the move

Recommendation:

Approval of this budget amendment will allow the Information Systems department to address an urgent infrastructure issue while aligning with strategic goals for centralized operations. The health, safety, and operational benefits justify the immediate allocation of funds.

<u>Section 1</u>: The Village of Royal Palm Beach hereby amends its Fiscal Year 2025-2026 budget as provided in the schedule attached hereto as Exhibit "A" and made a part hereof, in accordance with the terms and provisions of the Budget Resolution No. 25-26.

<u>Section 2</u>: The Village Clerk is hereby directed to attach a copy of this Resolution amending the Fiscal Year 2025-2026 Budget to the Fiscal Year 2025-2026 Budget documents and this Resolution shall be made a part of said budget.

Section 3: This Resolution shall take effect immediately upon adoption by the Village Council.
