#### Agenda Item Summary

#### **AGENDA ITEM:**

**Approval and authorization for the Village Manager to execute the second addendum to extend the Geotechnical & Environmental Engineering Services provided by Terracon Consultants, Inc. for the final two-year renewal period.**

#### **ISSUE:**

On June 19, 2021, the Village Council entered into an Agreement for Geotechnical & Environmental Engineering Services with Terracon Consultants, Inc. The original Agreement allowed for two additional two-year extensions upon the mutual agreement of the parties.

This request is to extend the Agreement for the second and final two-year term from June 20, 2025 until June 19, 2027 on the same terms and conditions as provided in the original Agreement.

THIS SECOND ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES BY AND BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND TERRACON CONSULTANTS, INC. (“Second Addendum”), made and entered into this \_\_\_\_ day of April, 2025, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the “Village”, and Terracon Consultants, Inc., with principal address at 10841 S. Ridgeview Road, Olathe KS, 66061, hereinafter referred to as “Consultant”, both of whom agree that the current “Agreement for Professional Services” regarding Geotechnical & Environmental Engineering Services made and entered into by the Village and Consultant on the 19th day of June, 2021, and amended by the First Addendum to Agreement for Professional Services By and Between The Village of Royal Palm Beach and Terracon Consultants, Inc., October 23, 2023 effective retroactively as of June 20, 2023 (hereinafter the “Agreement”), is hereby amended in the following manner:

Section 1: The above-referenced Agreement regarding Geotechnical & Environmental Engineering Services is hereby extended from June 20, 2025 through June 19, 2027 on the same terms and conditions as provided in the Agreement. This is the second and final two-year extension of the term of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: This Second Addendum shall be attached to the current Agreement and shall become a part thereof.
