**FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL
ARCHITECTURAL DESIGN SERVICES**

THIS FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL ARCHITECTURAL DESIGN SERVICES (“FIRST ADDENDUM”), made and entered into this ____ day of _____, 20____, effective January 19, 2026, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the “Village”, and REG Architects, Inc., with a principal address at 120 S. Olive Avenue, Suite 210, West Palm Beach, FL 33401, hereinafter referred to as “Consultant”, both of whom agree that the current Agreement for Professional Architectural Design Services (“Agreement”) made and entered into by the Village and Consultant effective January 19, 2024, is hereby amended in the following manner:

Section 1: The above-referenced Agreement is extended and shall run from January 19, 2026 through January 18, 2028 at the same terms and conditions as provided therein. This is the first extension of the term of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: All other Sections and recitals of the above-referenced Agreement shall remain in full force and effect.

Section 3: This First Addendum shall be attached to the current Agreement and shall become a part thereof.
