Issue:

The applicant is requesting a special event permit in order to hold a "5K Run and Walk with Dogs" at Commons Park. The event will take place on Saturday, July 23, 2022 from 7:30 a.m. until 12:00 p.m. Staff has reviewed this application and determined that the proposed event will not adversely affect the immediate area.

Recommended Action:

Approval of Special Event Permit, subject to the attached conditions (Exhibit A).

- 1. The event may only occur on Saturday, July 23, 2022 from 7:30 a.m. until 12:00 p.m.
- 2. Any tents used shall be flame resistant.
- 3. A Business Tax Receipt is required and permits must be obtained for all temporary electrical services, generators or temporary power poles and must be inspected prior to commencement of sales.
- 4. All electrical circuits shall be GFI protected.
- 5. Signage shall be set back at least 10 feet from the property line and shall not interfere with sight lines along public roadways and shall conform to the requirements of Sec. 20-71 of the Village Code of Ordinances.


