PUBLIC HEARING TO APPROVE RESOLUTION 22-15, A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, PROVIDING FOR THE APPROVAL AND AUTHORIZATION FOR THE WESTERN ACADEMY CHARTER SCHOOL TO UTILIZE THE OFFICIAL VILLAGE MUNICIPAL SEAL AS PART OF THE UPCOMING 8TH GRADE GRADUATION; FURTHER PROVIDING THAT THIS USE IS FOR A PROPER CIVIC PURPOSE; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES. Issue:

The Western Academy 8th Grade Graduation Celebration Committee has requested that the Western Academy Charter School be permitted to use the official Village Seal as part of their upcoming 8th Grade Graduation Celebration per the attached request included in Exhibit "A." Per the request, "[t]he logo would be used in conjunction with any words of encouragement or advice the Mayor and Village Council may offer to the Graduates in the student programs and signage which would be sprinkled throughout the upcoming Graduation Celebration on May 25th at the Royal Palm Beach Cultural Center."

Section 2-4 of Village Code provides that the Village Council may grant written approval for the use of the official Village Seal upon application by any person showing good cause for the use of the Seal for a proper civic purpose. Village Staff recommends a finding by the Village Council that the 8th Grade Graduation Celebration is a proper civic purpose.

RESOLUTION NO. 22-15

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, PROVIDING FOR THE APPROVAL AND AUTHORIZATION FOR THE WESTERN ACADEMY CHARTER SCHOOL TO UTILIZE THE OFFICIAL VILLAGE MUNICIPAL SEAL AS PART OF THEIR UPCOMING 8TH GRADE GRADUATION CELEBRATION; FURTHER PROVIDING THAT THIS USE IS FOR A PROPER CIVIC PURPOSE; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Village of Royal Palm Beach has designated an official municipal seal pursuant to Sec.165.043, *Florida Statutes*, through the adoption of Ordinance No. 471 as codified at Sec. 2-4. of the Village Code of Ordinances; and

WHEREAS, Sec. 2-4. of Village Code provides that the Village Council may grant written approval for the use of the official Village Seal upon application by any person showing good cause for the use of the Seal for a proper civic purpose; and

WHEREAS, the Western Academy 8th Grade Graduation Committee has requested that the Western Academy Charter School be permitted to use the official Village Seal as part of its upcoming 8th Grade Graduation Celebration; and

WHEREAS, the Village Council of the Village of Royal Palm Beach desires to approve the use of the official Village Seal for such purposes given that the 8th Grade Graduation Celebration is a proper civic purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, THAT:

Section 1: The Village Council of the Village of Royal Palm Beach hereby grants approval for the Western Academy Charter School to use the official Village Seal as part of its upcoming 8th Grade Graduation Celebration scheduled for May 25, 2022, pursuant to their request which is attached hereto as Exhibit "A," given that such use is for a proper civic purpose benefitting the Village and its residents. No other persons or entities shall be permitted to manufacture, use, display, or reproduce the official Village Seal without approval by the Village Council. The approval granted by this Resolution may be withdrawn by the Village Council at any time.

Section 2: This Resolution shall take effect immediately upon its adoption by the Village Council.
