Approval and authorization for the Village Manager to enter into a contract with A Cut Above Landscape & Maintenance, Inc. the lowest responsible, responsive bidder for the construction of landscape improvements for the Okeechobee Boulevard W Landscape Improvement Project, PW2006 in an amount not to exceed \$235,812.58.

Issue:

The Public Works Department solicited and opened bids for the Okeechobee Boulevard W Landscape Improvement Project, PW2006 on May 11, 2022. The Public Works Department evaluated the bids and calculated the adjusted bids for each bidder based on the number of days each company bid. The company with the lowest adjusted bid is A Cut Above Landscape & Maintenance, Inc. as shown on the attached bid tabulation. We are requesting approval to enter into a contract with A Cut Above Landscape & Maintenance, Inc., the lowest responsive, responsible bidder, to construct the Okeechobee Boulevard W Landscape Improvement Project, PW2006, in accordance with the approved plans and specifications, in an amount not to exceed \$235,812.58.
