FIRST ADDENDUM TO PROVISION OF SERVICES AGREEMENT BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND HAVERLAND AG INNOVATIONS, INC.

THIS FIRST ADDENDUM TO PROVISION OF SERVICES AGREEMENT BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND HAVERLAND AG INNOVATIONS, INC. ("First Addendum") is hereby entered into this ____ day of August, 2022, effective October 1, 2022, by and between the Village of Royal Palm Beach, a municipal corporation, ("Village") having its principal office located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, Florida, 33411; and Haverland AG Innovations, Inc., a Florida corporation having its principal place of business address at 3541 High Ridge Road, Boynton Beach, Florida, 33426 ("Consultant").

WHEREAS, the Village and Consultant entered into a Provision of Services Agreement Between the Village of Royal Palm Beach and Haverland AG Innovations, Inc. ("Agreement") on October 26, 2021 with an initial term expiring October 1, 2022; and

WHEREAS, the Agreement provides that the Village has the option of extending the Agreement for two (2) additional one-year periods on the same terms and conditions, with such extension required to be in the form of a written amendment to the Agreement executed by both parties; and

WHEREAS, the Village and Consultant desire to renew the Agreement for the first one-year renewal term.

NOW, THEREFORE, and in consideration of mutual terms, conditions, promises, covenants and payments hereinafter set forth, the Village and Consultant agree as follows:

Section 1: The above-referenced Agreement is renewed such that it shall run from October 1, 2022 until October 1, 2023. This is the first renewal of the Agreement as permitted by the provisions of the Agreement at Section 4.

Section 2: All other Sections and recitals of the above-referenced Agreement shall remain in full force and effect.

Section 3: This First Addendum shall be attached to the current Agreement and shall become a part thereof.
