## Agenda Item #: C - 7

Agenda Item: Approval and authorization to request <u>royalpalmbeachFL.gov</u> domain name from .gov Registrar, and to adopt <u>www.royalpalmbeachFL.gov</u> as Village's official website address.

When government organizations use a .gov domain name to serve the public on the internet, they make it easy to know that their services are official. Every request for a .gov domain name is carefully examined by the DotGov program to ensure it is from a genuine U.S.-based government or public sector organization.

Adopting a .gov domain name gives users confidence the information is from a trusted official government site and emails they receive from that particular domain are genuine.

The Cybersecurity & Infrastructure Security Agency (www.cisa.gov) is currently offering .gov domain names to U.S.-based government organizations at no cost, to include no ongoing renewal costs.

.Gov domain name registration requires the following:

- Signed Authorization Letter from the Municipality highest elected official authorizing request for .gov domain name.
- The State abbreviation "FL" be included in the municipality domain name.

The Village will retain ownership of domain names <u>www.royalpalmbeach.com</u>, <u>www.RpbFL.net</u>, and <u>www.Rpbfl.com</u> for web forwarding.

Recommended Action: Staff recommends Council authorize request for .gov domain name and adopt Village's website address www.royalpalmbeachFL.gov.
