#### **Agenda Item:**

Requesting ratification of the emergency purchase of a van from Duval Ford in the amount of \$59,394.00 by piggybacking the Florida Sheriffs Association Cooperative Purchasing Program. Funding source is from CIP Project PW22TR, Truck Replacement.

#### **Issue:**

Last year when attempting to purchase through the Florida Sheriffs Association Cooperative Purchasing Program, Public Works experienced a limited window of time to order a van through this program and we were not able to purchase the van last fiscal year. The cooperative purchase program for this van opened this year and we issued an emergency purchase order, P.O. No. 230008, to secure the purchase of the needed truck.
