SECOND ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES
BY AND BETWEEN
THE VILLAGE OF ROYAL PALM BEACH
AND
DHGA DESIGN-FL, LLC

THIS SECOND ADDENDUM, made and entered into this 20th day of January, 2023, effective on the 25th day of February, 2023, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the “Village”, and DHGA Design-FL, LLC, with mailing address at 225 Southern Blvd. Suite 202 West Palm Beach, FL 33405, hereinafter referred to as “Consultant”, both of whom agree that the current “Agreement for Professional Services” regarding Architectural Services made and entered into by the Village and Consultant on the 25th day of February, 2019, as amended by the “First Addendum to Agreement for Professional Services” by and between the Village of Royal Palm Beach and DHGA Design-FL, LLC dated January 22, 2021, is hereby amended in the following manner:

Section 1: The above-referenced Agreement regarding Architectural Services is extended to run from February 25, 2023 until February 24, 2025. This is the second and final extension of the term of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: All other Sections and recitals of the above-referenced Agreement shall remain in full force and effect.

Section 3: This Addendum shall be attached to the current Agreement and shall become a part thereof.

IN WITNESS WHEREOF, the Village has caused this Second Addendum to be signed and executed on its behalf by its Village Manager; and DHGA Design-FL, LLC, has signed and executed this Second Addendum, with an effective date as noted above.
