- 1. The event may only occur on March 25, 2023, from 9:00 a.m. to 1:00 p.m.
- 2. Any tents used shall be flame resistant.
- 3. All electrical circuits shall be GFI protected.
- 4. Signage shall be set back at least 10 feet from the property line and shall not interfere with sight lines along public roadways and shall conform to the requirements of Sec. 20-71 of the Village Code of Ordinances.
- 5. The applicant shall provide for portable restroom facilities including at least one handicapped accessible facility if public facilities are not within 500' of accessibility.
- 6. If trailer is to be used on site for security purpose, the applicant shall obtain temporary trailer permit from the Village Building Department. This trailer may trailer permit from the Village Building Department. This trailer may not be used for overnight sleeping purposes.
- 7. Adequate provision shall be made for overflow parking.
