### Agenda Item:

Requesting ratification of the emergency purchase of a van from Duval Ford in the amount of \$75,896.00 by piggybacking the Florida Sheriffs Association Cooperative Purchasing Program. Funding source is from CIP Project PW22TR, Truck Replacement.

#### Issue:

Last October 2022, Public Works issued a purchase order for a van piggybacking off of the Florida Sheriffs Association Cooperative Purchasing Program. Ford Motor Company cutoff the 2023 & 2024 production of the model van we had ordered. Duval Ford has another model van in stock that the Village can purchase off the Florida Sheriffs Association Cooperative Purchasing Program. This van is a larger model than the one we ordered but will work for the use we intend to use it for. Public Works is requisitioning an emergency purchase order to secure the purchase of the needed truck.
