RESOLUTION NO. 23-30

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, RECOGNIZING “YOUTH BASEBALL ASSOCIATION OF ROYAL PALM BEACH, INC.” AS THE PRIMARY PROVIDER OF YOUTH BASEBALL AND YOUTH SOFTBALL IN THE VILLAGE OF ROYAL PALM BEACH; PROVIDING FOR PERIODIC UPDATES AND AN ANNUAL REVIEW OF THE PROGRAM BY THE VILLAGE RECREATION ADVISORY BOARD; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Village Council of Royal Palm Beach has assumed a leadership role in promoting the health and welfare of the youth in the Village by providing baseball complexes for both recreational and competition purposes; and

WHEREAS, there is a need for organized youth baseball and youth softball programs to maximize the best use of such baseball complexes; and the Village has adopted updated “Primary Sports Provider Policies and Procedures” through the approval of Resolution No. 23-29 on August 17, 2023; and

WHEREAS, a single organized baseball and softball program in the Village of Royal Palm Beach will provide opportunities for a balanced athletic program and team sports to develop basic skills and sportsmanship for young people; and

WHEREAS, Youth Baseball Association of Royal Palm Beach, Inc. wishes to provide successful youth baseball and youth softball programs in the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, THAT:

Section 1. The Village Council of the Village of Royal Palm Beach hereby recognizes “Youth Baseball Association of Royal Palm Beach, Inc.” (the “Provider”) as the Primary Provider of youth baseball and youth softball programs in the Village in accordance with “Primary Sports Provider Policies and Procedures” (the “Policies”) for a period of five (5) years from the date of execution of the Policies by both the Village and the Provider, unless this recognition as the Primary Provider is terminated earlier by the Village Council in accordance with the Policies.

Section 2. Youth Baseball Association of Royal Palm Beach, Inc., will provide the Village with periodic updates on the baseball and softball programs and its financial status along with an annual review of the state of its organization to the Recreation Advisory Board.

Section 3. This resolution shall take effect immediately upon adoption.

Section 4. The Village of Royal Palm Beach Parks and Recreation Director shall appoint a liaison to serve as a non-voting member of the Youth Baseball Association of Royal Palm Beach, Inc.
