AGENDA ITEM:

Approval and authorization for the Village Manager to execute an addendum to Extend Geotechnical & Environmental Engineering Services provided by Terracon Consultants Inc. for two years.

ISSUE:

On June 20, 2019, the Village Council entered into an agreement for Professional Services in connection with Geotechnical & Environmental Engineering Services with Terracon Consultants Inc. The original agreement allowed two additional two-year extensions. This will be the first extension to the professional service agreement. The referenced Agreement regarding Surveying Services will be extended retroactively to run from June 20, 2023 until June 19, 2025 on the same terms and conditions as provided in the Agreement.

THIS FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES BY AND BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND TERRACON CONSULTANTS, INC. ("First Addendum"), made and entered into this

_____ day of October, 2023, effective retroactively as of June 20, 2023, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the "Village", and Terracon Consultants, Inc., with principal address at 10841 S. Ridgeview Road, Olathe KS, 66061, hereinafter referred to as "Consultant", both of whom agree that the current "Agreement for Geotechnical & Environmental Engineering Services" made and entered into by the Village and Consultant on the 19th day of June, 2021, (hereinafter the "Agreement"), is hereby amended in the following manner:

Section 1: The above-referenced Agreement regarding Geotechnical & Environmental Engineering Services is hereby extended retroactively from June 20, 2023 through June 19, 2025 on the same terms and conditions as provided in the Agreement. This is the first two-year extension of the term of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: This First Addendum shall be attached to the current Agreement and shall become a part thereof.
