AGENDA ITEM:

Approval and authorization for the Village Manager to execute an addendum to Extend Electrical Services provided by Smith Engineering Consultants Inc. for two years.

ISSUE:

On June 20, 2019, the Village Council entered into an agreement for Professional Services in connection with Electrical Services with Smith Engineering Consultants Inc. The original agreement allowed two additional two-year extensions. This will be the second and final extension to the professional service agreement. The referenced Agreement regarding Surveying Services will be extended retroactively to run from June 20, 2023 until June 19, 2025 on the same terms and conditions as provided in the Agreement.

SECOND ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES BY AND BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND SMITH ENGINEERING CONSULTANTS, INC.

THIS SECOND ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES BY AND BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND SMITH ENGINEERING CONSULTANTS, INC. ("Second Addendum"), made and entered into this _____ day of October, 2023, effective retroactively as of June 20, 2023, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the "Village", and Smith Engineering Consultants, Inc., with mailing address at 2161 Palm Beach Lakes Boulevard, Suite 312 West Palm Beach, FL 33409, hereinafter referred to as "Consultant", both of whom agree that the current "Agreement for Professional Services" regarding Electrical Engineering Services made and entered into by the Village and Consultant on the 20th day of June, 2019, and amended by the First Addendum to Agreement for Professional Services By and Between The Village of Royal Palm Beach and Smith Engineering Consultants, Inc., effective June 20, 2021, (hereinafter the "Agreement"), is hereby amended in the following manner:

Services is extended retroactively to run from June 20, 2023 until June 19, 2025 on the same terms and conditions as provided in the Agreement. This is the second and final two-year extension of the term of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: This Second Addendum shall be attached to the current Agreement and shall become a part thereof.
