PUBLIC HEARING TO CONSIDER APPLICATION NO. 23-059 (AAR), THE APPLICANT, MPLD CONSULTING, ON BEHALF OF CRESTWOOD SQUARE LTD, IS REQUESTING ARCHITECTURAL AND AESTHETIC REVIEW (AAR) APPROVAL FOR A COVERED OUTDOOR SEATING/DINING AREA EXPANSION OF AN EXISTING RESTAURANT, FOR A PROPERTY LOCATED AT 11935 SOUTHERN BOULEVARD.

Issue:

The Applicant, MPLD Consulting, on behalf of Crestwood Square LTD, is requesting Architectural and Aesthetic Review (AAR) Approval for a covered outdoor seating/dining expansion of an existing restaurant Duffy's Sports Grill within the Crestwood Square shopping center, for a property located at 11935 Southern Boulevard. The Applicant is proposing to expand the existing outdoor seating/dining area from 300 square feet to 1,320 square feet, and provide new elevations for the affected area of the building's west, south and east facades. According to the Applicant's Justification Statement, the proposed expansion of the existing outdoor seating/dining area is to improve the overall dining experience for customers.

The Planning and Zoning Commission considered the application on October 24, 2023, and recommended Approval by a vote of 5-0.




