**The following action was taken:**

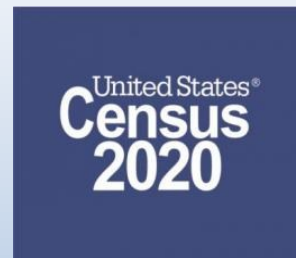
- Tentative Adoption of Proposed Millage rate of 1.9200 and Public Budget Hearings scheduled for 6:30 p.m. on September 8th and 17th.
- Approved Second Addendum to Musco Sports Lighting, LLC for Commons Park lighting for \$189,500.00.
- Approval Change Order #1 with Davco Electrical Contractors Corp. for lighting at Commons Park for \$121,356.66.
- Approved bid award to Seeds Café, LLC for the use of the café at Veterans Park for a monthly lease of \$300.00.
- Approved renewal contract with Call a Doctor Plus, and CIGNA Healthcare to provide Health, Dental, and Life/ Disability Insurance for employees.
- Approved Site Plan Modification and Architectural Approval for a new multipurpose building and modifications to the Village Hall complex.
- Approved Preliminary Plat for 4 parcels of land totaling 33.748 acres (POD 4) located on the south side of Acme Road and west of S.R. 7.
- Approved Architectural for 10 additional home models for Crestwood North Residential PUD, denied shingled roof request.
- Approved Preliminary Plat for 14.22 acres at 10701 Okeechobee Blvd.
- Approved Landscape Waivers for 10701 Okeechobee Blvd.

- Approved Site Plan Modification and Architectural Approval for a new Worship Hall, accessory buildings and to expand the existing 8.67 church site located at 10701 Okeechobee Blvd.
- Approved first reading of Ord. 1002 to allow Electric Vehicle Charging Stations as accessory uses within certain zoning districts.
- Approved first reading of Ord. 1001 amending Chapter 26 to allow adult day care centers as a permitted use in CG—General Commercial Zoning District.
