Call the Village of Royal Palm Beach's Engineering Department at (561) 790-5103 for access to FEMA's Flood Insurance Rate Maps (FIRM) for our village, and to learn if a property is in a Special Flood Hazard Area, and if it may be affected by local drainage problems, or is in an area that has previously had flooding problems, and to see if your property is located near an area that should be protected because of its natural floodplain functions. Village staff is available to provide property protection consultations including site visits and drainage evaluations on your property.

**Virtual Council Regular Meeting
was called to order at 6:30 P.M.
Thursday, November 18, 2021**

The following action was taken:

- Approved purchase of playground apparatus for Veterans Park from Miracle Recreation Equip. Co. for \$150,000 .
- Approved agreement with Sport Surfaces LLC for resurfacing various sport courts and creating 4 pickleball courts not to exceed \$105,000.
- Adoption of Res. 21-20 making a year-end budget adjustment for Fund 001 in FY2020/2021 Budget that appropriates \$178,300 Utility Taxes, Federal Grants Public Assistance and Other (FEMA Covid), Police Education and Legal Fees and increase amounts budgeted in the Legal, Police and PW departments.
- Approved addendum to extend Village Hall Architectural and Design Services with REG Architects, Inc. for 2 years.
- Cancel award of contract to National Traffic Control Systems, Inc. in the amount of \$757,764.00 for Commons Park Pathway Lighting.
- Reject all bids received and opened at 3:00 p.m. on Friday, Oct. 6, 2021 for Commons Park Pathway Lighting.
- Adopted Res. 21-21. Western Academy Holdings, LLC seeking approval by local gov't to use of the proceeds of the bonds within the Village in accordance with the Tax Equity and Fiscal Responsibility Act Section 147(f) of the IRS Code of 1986 located at 12031 Southern Blvd.
- Adopted Ord. 1014 amending Chapter 20—Signs and create definitions for select terms related to sign identification and regulations and to conform to recent legal precedent regarding signs and to provide internal consistency.
- Adopted Ord. 1021 amending Chapter 11. Fire Prevention and Protection., Section 11-23 Propane Storage in order to better conform with industry standards relative to tank sizes.
- Approved first reading of Ord. 1020 amending Chapter 9. Fences, hedges and walls. to add exemption to the permit requirement for fence repairs at 25% and revise existing regulations to require certain fences to be constructed with finished side to adjoining lot or right-of-way.
