CONSENT TO PARTICIPATE, RELEASE AND LIABILITY WAIVER

I understand that participation can involve many RISKS and INJURIES, including, but not limited to, death, serious neck and spinal injuries and other serious injuries or impairment to the body.

As the parent/legal guardian of a minor or as a participant in activities of the Parks & Recreation Department, I hereby agree to hold the Village of Royal Palm Beach, its employees, agents, representatives, coaches and volunteers harmless from any and all liability, actions, causes of action, debts, claims or demands of any kind and nature whatsoever which may arise by or in connection with my participation or the participation of my child/ward in activities related to the Recreation Department Programs.

The terms hereof shall serve as a release for my heirs, estate, executor, and administrator, assignees and for all members of my family.

I am the participant in the Village of Royal Palm Beach Parks and Recreation Department Activity (the "Activity"), or I am the parent or legal guardian of the minor child/ward participant in the Activity. I know of no reason, physical or otherwise, why I as the participant or my child/ward participant is not able to participate in the Activity. I understand and agree that participation is a privilege. I agree that I, as the participant, or I and my child/ward participant, will follow the rules of the Village and abide by the Village's decisions with respect to the Activity. I understand the risks involved in Activity participation, and that I, as the participant, or I and my child/ward participant, may suffer property damage, neck and spinal injuries, other serious injuries or impairment, and even death, while acting as a participant in the Activity or while merely observing or being present at the Activity. I, as the participant, or I, for myself, if I am the parent or legal guardian of a minor child/ward participant, do hereby knowingly and voluntarily agree to assume any and all such risks, both known and unknown, associated with the Activity. As a parent or legal guardian of a minor child/ward participant, if applicable, I, on behalf of the minor child/ward participant, do hereby knowingly and voluntarily agree to assume all inherent risks, known or unknown, which are characteristic of, intrinsic to, or an integral part of the Activity and which are not eliminated even if the Village, its officials, employees, representatives, agents, contractors and volunteers act with due care in a reasonably prudent manner (hereinafter "Inherent Risks").

In consideration for me or my minor child/ward being allowed to participate in the Activity, I, as the participant, or I, as the parent/legal guardian of the minor child/ward participant, on behalf of myself, do hereby agree to unconditionally release, waive, discharge, hold harmless, and covenant not to sue the Village of Royal Palm Beach, Florida, its officials, employees, representatives, agents, contractors and volunteers (the "Releasees"), for or from any and all liability, claims, actions, damages, costs or expenses of any kind whatsoever including trial and appellate attorney's fees which I may have or my personal representatives, legal representatives, administrators, assigns, heirs and next of kin may have, and which arise out of, are related to, are in any way connected with, or are as a result of my or my child/ward's participation in the Activity, presence at the Activity, or travel associated with the Activity including, but not limited to, claims based on release, waive, discharge, hold harmless, and covenant not to sue the Village of Royal Palm Beach, Florida, its officials, employees, representatives, agents, contractors and volunteers (the "Releasees"), for or from any and all liability, claims, actions, damages, costs or expenses of any kind whatsoever including trial and appellate attorney's fees which my minor child/ward may have or his/her personal representatives, legal representatives, administrators, assigns, heirs and next of kin may have, and which arise out of, are related to, are in any way connected with, or are as a result of the Inherent Risks associated with my child/ward's participation in the Activity, presence at the Activity, or travel associated with the Activity as defined in Section 744.301, Florida Statutes.

ADDENDUM TO CONSENT TO PARTICIPATE, RELEASE AND LIABILITY WAIVER

This form was created to comply with the provisions of Fla. Stat. § 744.301, as it relates to the enforceability of a waiver or release executed by a parent/guardian on behalf of their minor child/ward. This addendum applies to the parent/guardian waiving the right of a minor child/ward in advance of the child/ward's participation in an Activity. This form must be signed by all parents/guardians of a child/ward if such child/ward is under age 18.

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF THE VILLAGE OF ROYAL PALM BEACH, ITS OFFICIALS, EMPLOYEES, REPRESENTATIVES, AGENTS, CONTRACTORS AND VOLUNTEERS (THE "RELEASEES") USE REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM THE RELEASEES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND THE VILLAGE HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.
