## **Dog Park Rules:**

- (1). If your dog plays inappropriately, interrupt it. If it becomes aggressive, it must be removed from the park IMMEDIATELY!
- (2).DO NOT leave the gate open at any time!
- (3). You must monitor you dog at all times. If your dog eliminates it is to be picked up and disposed of immediately.
- (4). Please be advised, dogs can over heat quickly in the Florida sun. Keep your dog from over heating by interrupting play periodically, and consider hosing them down or going in to the shade for a while.
- (5.) All dogs must be on a leash in the parking lot and on the way into and out of the park. Owners are to have a leash with them at all times while in custody of a dog.
- (6). All dogs must have current rabies shots and all other vaccines as required by the Village of Royal Palm Beach and must have current rabies tag displayed in ready view (Ordinance #137)
- (7). Do not bring puppies under 4 months old into park. They are still susceptible to disease, even if they have had their shots. It takes time for the shots to confer immunity.
- (8). If your dog digs it must be interrupted immediately.
- (9). Limit the number of dogs that you adequately supervise Limit 3.
- (10). Dogs in heat, dogs that are sick, dogs with internal or external parasites (fleas, ticks, worms) and aggressive dogs are not allowed in the park.
- (11). People who violate these rules are subject to removal from the park and possible suspension from park use.

The park is for everyone. Please have fun, be safe, and be courteous to your neighbors and their dogs.

## **Dog Park treatment:**

**Suspend SC (Deltamethrin**): Aduticide for adult feeding ticks/fleas and other target insects. Re-entry time of product is solution being dry. **Archer (Pyriproxyfen)**: IGR (Insect Growth Regulator) for non-adult stages of the fleas and ticks and any other target insects. Prevents maturity into feeding adults and effects adult reproductive organs to prevent new hatchlings. Re-entry time of product is solution being dry. **Cedarcide wood grannules**: Ground cedar chips for the repelling of fleas/ticks and any other target insects. Biobased product certified through the USDA. Uses natural cedar oil from Cedar trees/shrubs

Additional treatments may be needed after determining severity of insect infestations in each park.

Products have proven effectiveness and warrantied in the industry. Village of Royal Palm Beach cannot control all new insect introductions in park due to infestations on actual animals. Please check and treat your pet if needed before entering the park.
