 Ordinance 1018 proposes to amend the Village's Code of Ordinances at Chapter 26 – Zoning at Sec. 26-22 to add entirely new definitions for the terms "primary structure" and "shed" and at Sec. 26-27 to clarify the setback calculations for sheds and play structures with design features exceeding eight (8) feet in height.

Ordinance 1020 proposes to amend the Village's Code of Ordinances at Chapter 9 – Fences, hedges and walls at Sec. 9-1 to add an exemption for repairs or replacement less than 25% of the permitted installation and at Sec. 9-8 to revise currently regulations for residential-zoned property to require the presentation of "finished side" out in certain instances.
