Application No. 22-63 (TEXT) – Royal Palm Brewing Company – The applicant, Royal Palm Brewing Company, is requesting a Text Amendment to the Village's Zoning Code to amend Secs. 26-75.2 and 26-89 to eliminate the current prohibition on outdoor seating and patron congregation directly abutting residential zoning districts which would allow for such use subject to variance approval by Village Council and to increase the square footage limitation for brewpubs and microbreweries from 5,000 to 6,000 square feet, specifically requested for a property located at 543 N. State Road 7, Suite 103.
