 Application No. 23-186 (SCPA) Primrose Schools Parking Lot – The Applicant, Bar Education, Inc., is requesting a Small Scale Comprehensive Plan Amendment to change the future land use designation of one parcel totaling 0.235± acres from the Village's Open Space (OS) Land Use Designation to the Village's Industrial (IND) Land Use Designation, for a property located at 6846 Seminole Palms Drive.
