1. Application No. 23-164 (SPM, SE, AAR) Primrose College Use – The Applicant, Bar Education, Inc., is requesting Site Plan Modification to modify the previously approved site plan, Special Exception Approval to modify the use of the 300 Building to allow for college use as part of the existing "Private Academic Institution" in lieu of the existing middle school use, and Architectural Approval to modify the wall signage on the northern facade of the 300 Building, for a property located at 300 and 400 Royal Commerce Road.
