Agenda Item:

Approval of bid award and authorization for the Village Manager to enter into contract with U.S. Sweeping, Inc., the lowest responsive, responsible bidder, in the amount of \$26,348.41 for Street Sweeping. Funding source is from the Stormwater Utility operating budget.

Issue:

Street Sweeping is part of the maintenance of the streets within the Village and is an identified BMP in our NPDES permit. This contract is for a one (1) year term and may be extended for two (2) additional one (1) year term provided both parties agree.
