**FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS FIRST ADDENDUM, made and entered into this \_\_\_\_ day of September, 2019, effective retroactively as of the 12<sup>th</sup> day of March, 2019, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, FL 33411, hereinafter referred to as the “Village”, and MY PR Guru, with mailing address at 11419 W. Palmetto Park Road, #971402, Boca Raton, FL 33497, hereinafter referred to as “Consultant”, both of whom agree that the current “Professional Services Agreement” regarding Communication Plan Services (herein after the “Agreement”) made and entered into by the Village and Consultant on the 12<sup>th</sup> day of March, 2018, is hereby amended in the following manner:

Section 1: The above-referenced Agreement regarding Communication Plan Services is extended from March 12, 2019 through March 12, 2020. This is the first extension of the term of the Agreement as permitted by the provisions of the Agreement at Section 1.

Section 2: All other Sections and recitals of the above-referenced Agreement shall remain in full force and effect.

Section 3: This Addendum shall be attached to the current Agreement and shall become a part thereof.
