AGENDA ITEM:

ADOPTION OF RESOLUTION 20-06, A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, APPROVING AN APPLICATION TO THE TRANSPORTATION ALTERNATIVES GRANT PROGRAM THROUGH THE PALM BEACH TRANSPORTATION PLANNING AGENCY FOR THE INSTALLATION AND MODIFICATION OF CURB RAMPS AND SIDEWALK CONNECTIONS IN THE LA MANCHA AND SARATOGA PINES SUBDIVISIONS TO MEET CURRENT ADA STANDARDS, AND COMMITTING TO FUND ONGOING OPERATIONS AND MAINTENANCE THROUGH THE USEFUL LIFE OF THE PROJECT; AUTHORIZING THE MAYOR OR VILLAGE MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

ISSUE:

The Village is submitting an application to the Palm Beach Transportation Planning Agency for the 2020 Transportation Alternatives Grant Program for the Capital Project, EN2302 ADA Improvements Phase II. The requested grant funding will be approximately \$600,000, and the Village will be funding approximately \$150,000. The project proposes to add or rebuild ADA-accessible concrete sidewalks in the La Mancha and Saratoga Pines subdivisions. This will provide a safe and convenient place for all pedestrians to cross the street, without needing to walk over grass or through the driveway.

WHEREAS, the Village Council recognizes that alternative methods of transportation are important aspects of our Village planning efforts; and

WHEREAS, it is incumbent upon community leaders to ensure the safety and welfare of residents and visitors in Royal Palm Beach; and

WHEREAS, the Village of Royal Palm Beach wishes to construct or modify curb ramps and sidewalks throughout the Village to meet current Americans with Disabilities Act (“ADA”) Standards and apply for funding related to the system, and apply for funding related to the network.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF ROYAL PALM BEACH, FLORIDA, THAT:

Section 1: The Village Council hereby approves The Village’s application for Transportation Alternatives Grant Program funding for EN2302 ADA Improvements Phase II to support the Village’s continued efforts for safety and aesthetics on Village roadways.

Section 2: The Village Council hereby authorizes the Mayor or Village Manager to do all that is necessary to make application for this Transportation Alternatives Grant Program funding through the Palm Beach Transportation Planning Agency.

Section 3: This Resolution shall take effect immediately upon adoption.
