Agenda Item:

PUBLIC HEARING TO CONSIDER VARIANCE APPLICATION 20-22 (VAR), AN APPLICATION BY DIANE COSGROVE, AND VARIANCE ORDER VC-20-3, THE APPLICANT IS REQUESTING A VARIANCE FROM SEC. 26-79 TO ALLOW FOR A REDUCED REAR SETBACK OF 15 FEET WHERE VILLAGE CODE REQUIRES 20 FEET, A VARIANCE OF FIVE (5) FEET, IN ORDER TO CONSTRUCT AN ADDITION, FOR A PROPERTY LOCATED AT 121 CYPRESS CRESCENT.

Issue:

The Applicant is requesting a Variance from Section 26-79 to allow for a reduced rear yard setback of 15-feet for the principal structure in lieu of the 20-foot rear yard setback, as required by Code, resulting in a variance of five (5) feet. The Applicant would like to construct an addition to the existing house. Please refer to **Attachment A** for an Illustration showing the location of the addition.

The Applicant asserts that the addition is for a nursery with a bathroom and closet. The Applicant contends that the variance request is necessary to accommodate their growing family and will allow them to stay in their current home, and not have to move from the neighborhood they love. It is the Applicant's position that the requested variance is the minimum variance which will allow reasonable use of the property, and that the variance will not confer on the Applicant special privileges.

The Village sent out the required mail notice to all residents within a 300-foot radius of the subject property, notifying property owners of the variance request. The Village did not receive any responses either supporting or objecting to the application. The applicant provided letters of support from adjoining neighbors supporting the variance request.

Village Code Sec. 26-32 (f) (6) allows the Village Council to grant variances to the code when:

• Special conditions and circumstances exist which are peculiar to the land, structure or building involved, and which are not applicable to other lands, structures or buildings subject to similar requirements;

- The special conditions and circumstances do not result from the actions of the applicant;
- Granting the variance request will not confer on the applicant any special privileges that are denied by this Code to other lands, buildings or structures similarly situated;
- A literal interpretation of the provisions in this Code would deprive the applicant of rights commonly enjoyed by other properties similarly situated under the terms of this Code and would work unnecessary and undue hardship on the applicant;
- The variance granted is the minimum variance that will make possible the reasonable use of the land, building or structure;
- The grant of the variance will be in harmony with the general intent and purpose of this division;
- Such variance will not be injurious to the area involved or otherwise be detrimental to the public welfare.

Village Staff is not in support of this variance because Staff believes that <u>no special</u> <u>conditions or circumstances exist which are not applicable to other lands</u>; the <u>condition is</u> <u>the result from actions of the applicant</u>; granting of the variance <u>will confer on the applicant</u> <u>special privileges that are denied to other lands</u>; the <u>literal interpretation of the Code does</u> <u>not deprive the applicant the rights enjoyed by other lands in the same zoning district</u>; and that it is <u>not the minimum variance necessary to allow reasonable use of the property</u>.

Recommended Action:


Staff is recommending Denial of Application 20-22 (VAR) and Variance Order VC 20-3.

ORDER APPROVING APPLICATION

This cause came to be heard upon the above application and the Royal Palm Beach Village Council having considered the evidence presented by the applicant and other interested persons at a hearing called and properly noticed, and the Royal Palm Beach Village Council being otherwise advised.

THEREUPON, the Village Council of the Village of Royal Palm Beach finds as follows:

- The property which is the subject of said application is classified and zoned within the RS-2 Single-Family Residential District by the Zoning Code of the Village of Royal Palm Beach and the zoning map made a part thereof by reference.
- 2. The applicant is seeking a **Variance** from Royal Palm Beach Code of Ordinances at the following section: Section 26-79 in order to allow for a reduced rear setback of fifteen (15) feet where Village Code requires a 20-foot rear setback, a variance of five (5) feet, for an addition.
- 3. Under the provisions of Sec. 26-32(f)(6) of the Village Code of Ordinances, the Village Council has the right, power and authority to act upon the application herein made.

The application for **Variance**, **VC-20-3**, with reference to the abovereferenced property in the Village of Royal Palm Beach, Florida to permit a variance to Section 26-79 in order to allow for a reduced rear setback of fifteen (15) feet where Village Code requires a 20-foot rear setback, a variance of five (5) feet, for an addition is hereby **Approved** in accordance with the Village Code of Ordinances for the following reasons:

<u>The applicant meets the following standards set forth in Section 26-32 (f)</u> (6). of the Village Code of Ordinances:

- 1. <u>Special conditions and circumstances exist;</u>
- 2. <u>Special circumstances are not the result of actions of the applicant;</u>
- 3. <u>No special privilege is conferred;</u>
- 4. <u>Literal interpretation would constitute an unnecessary and undue hardship;</u>
- 5. <u>This is minimum variance for reasonable use of land;</u>
- 6. <u>Is in harmony with the intent and purpose of this division; and</u>
- 7. <u>Will not be injurious to area or detrimental to the public welfare.</u>
