













- CY 2019: 10 cases


#### **Larceny Incidents**





- CY 2019 had 109 less Larceny incidents than CY 2018, a 15.8% decrease
- Shoplifting incidents accounted for 49.5% of all Larceny incidents
- Shoplifting increased 16.1%; from 205 to 238
- There were 118 Shoplifting arrests


## **Shoplifting Incidents**



#### CY 2019:


- Shoplifting Increased 16.1% from 205 in 2018 to 238 in 2019.
- The five big box stores had 71.4% (170 incidents) of all shoplifting cases reported.

- In CY 2019, Residential Burglary incidents increased 44%
- From CY 2015 to present, Residential Burglaries decreased
   74%
- Five burglaries were to empty residence/apartments and one case is domestic related.















## **Service Quality Survey**



#### CY 2020 Goals

- Reduce the amount of stolen vehicles through the utilization of electronic burglary & theft detection devices.
- Continuing to work with the Village of Royal Palm Beach on Ordinance updates.
- Promote the Police Athletic League (P.A.L.) Boxing Program through public participation at the annual Royal Palm Beach West Fest.
- Maintain a strong working relationship with the Village of Royal Palm Beach T.S.R. Board on law enforcement involvement in growth expansion coupled with CPTED principals.
- Continue to encourage communities to start Neighborhood Watch Programs and/or Crime Prevention Meetings.
- Continue the use of the unmarked fleet vehicles for surveillance and crime prevention.
- Continue the Annual Clergy & Principal Breakfast and expand to owners of Day Care Centers.
- Increased Financial and Internet Crimes continue to be one of the biggest challenges law enforcement has to face both locally and nationally. Continued education to the public through social media, printed and verbal communication is essential to minimize the impact on the community.
- The Procurement and installation of LPR cameras at certain locations within the District will assist in the identification and apprehension of criminals and assist in case closure.
- Continue to educate the public about the risks involved with leaving valuables in unlocked vehicles as well as removing key fobs or spare car keys.
- Increase participation in the Annual Unified Local Food & Turkey Drive.
- Reduce traffic crashes with special attention to major intersections.
- Continue Crime Reduction through expanded use of Directed Patrol Plans and Community Education.
- Continue to work closely with all schools, daycares and religious campuses within the Village of Royal Palm Beach to ensure proper training and response requirements will be met by the Sheriff's Office if an emergency or active shooter incident ever occurs.
