Village of Royal Palm Beach Village Council Agenda Item Summary

Agenda Item:

PUBLIC HEARING TO CONSIDER APPLICATION NO. 21-29 (AAR), THE APPLICANT IS SEEKING ARCHITECTURAL APPROVAL FOR THE VILLAGE ROYALE BRIDGE ON TUTTLE BOULEVARD OVER THE C-51 CANAL LOCATED SOUTH OF SOUTHERN BOULEVARD APPROXIMATELY 3,500 FEET EAST OF STATE ROAD 7; BY AGENT: YOAN MACHADO OF WGI, INC.

Issue:

The Applicant is requesting Architectural Approval for the Village Royale Bridge on Tuttle Boulevard over the C-51 Canal. The bridge is located south of Southern Boulevard and approximately 3,500 feet east of State Road 7. The Applicant is proposing carriage style light fixtures both pier mounted and pole mounted. All walls and columns will be Class Five Finish in Sherwin Williams Marshmallow SW7001. An ornamental aluminum railing with bronze finish will also be included and lay atop of the walls along with tiles on certain areas of the walls. Decorative pavers and design are also a part of this request. The decorative pavers are arranged such that they form palm fronds when viewed from above. Please refer to **Attachments A** for an illustration of the proposed Bridge.

Staff is recommending a Condition of Approval to require the Applicant to obtain a South Florida Water Management District (SFWMD) permit modification in order to make the SFWMD's approved plans consistent with the Village's approved plans. In the event the SFWMD denies the permit modification reflecting the proposed changes, the Applicant shall apply for modification of Engineering Permit 17-37 to ensure consistency with SFWMD's approved plans.

The Planning and Zoning Commission considered this Application at their June 29, 2021 meeting and recommended Approval of Application No. 21-29 (AAR) by a vote of 5-0.


Recommended Action:

Staff is recommending Approval of Application No. 21-29 (AAR) with the condition as stated above.



the application for Architectural approval, concerning the installation of decorative light fixtures, paint, aluminum railings, tiles and decorative pavers on the Village Royale Bridge with reference to the above-referenced property in the Village of Royal Palm Beach, Florida, as depicted in Exhibit "B" attached hereto and incorporated herein, is hereby **Approved** subject to the following condition:

Applicant shall obtain a South Florida Water Management District (SFWMD) permit modification in order to make the SFWMD's approved plans consistent with the Village's approved plans. In the event the SFWMD denies the permit modification reflecting the proposed changes, the Applicant shall apply for modification of Engineering Permit 17-37 to ensure consistency with SFWMD's approved plans

since the applicant meets the review criteria set forth in Section 2-75.28(b) and(e) of the Village Code of Ordinances.



