AGENDA ITEM:

Approval of the Village Manager to execute the Second Addendum to Provision of Services Agreement between the Village of Royal Palm Beach and ProChamps to extend the term of the Agreement for the second one-year renewal period, from March 10, 2022 through March 10, 2023.

ISSUE: The Village and ProChamps entered into a Provision of Services Agreement on December 20, 2019, effective as of October 1, 2019, for the provision of Foreclosure Registry Services which was based on a lawfully procured contract between ProChamps and Clay County (RFP# 18/19-21). The Agreement had an initial term expiration of March 10, 2021, with an option for the Village to extend the Agreement for two (2) additional one-year terms subject to annual appropriations by the Village and subject to fiscal funding by the Village. The Village entered into a First Addendum to the Agreement to utilize the first renewal period and extend the Agreement term from March 10, 2021 through March 10, 2022. The Village now wishes to enter into the Second Addendum to the Agreement to utilize the second and final renewal period and extend the Agreement term from March 10, 2022 through March 10, 2023.

SECOND ADDENDUM TO PROVISION OF SERVICES AGREEMENT BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND PROCHAMPS

THIS SECOND ADDENDUM TO PROVISION OF SERVICES AGREEMENT BETWEEN THE VILLAGE OF ROYAL PALM BEACH AND PROCHAMPS ("Second Addendum") is hereby entered into this _____ day of February, 2022, effective March 10, 2022, by and between the Village of Royal Palm Beach, a municipal corporation, ("Village") having its principal office located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, Florida, 33411; and ProChamps, a Florida Corporation having its principal place of business address at 2725 Center Place, Suite 200, Melbourne, Florida, 32940 ("Consultant").

WHEREAS, the Village and Consultant entered into a Provision of Services Agreement between the Village of Royal Palm Beach and ProChamps ("Agreement") on December 20, 2019, effective as of October 1, 2019, with an initial term expiring on March 10, 2021; and

WHEREAS, the Agreement provides that the Village has the option of extending the Agreement for two (2) additional one-year terms subject to annual appropriations by the Village and subject to fiscal funding by the Village; and

WHEREAS, the Village and Consultant entered into the First Addendum to Provision of Services Agreement on February 18, 2021, effective as of March 10, 2021, implementing the first renewal and extending the term through March 10, 2022.

NOW, THEREFORE, and in consideration of mutual terms, conditions, promises, covenants and payments hereinafter set forth, the Village and Consultant agree as follows:

Section 1: The above-referenced Agreement is renewed such that it shall run from March 10, 2022 until March 10, 2023. This is the second and final renewal of the Agreement as permitted by the provisions of the Agreement at Section 4.

<u>Section 2</u>: All other Sections and recitals of the above-referenced Agreement shall remain in full force and effect.

Section 3: This Second Addendum shall be attached to the current Agreement and shall become a part thereof.
