**SECOND ADDENDUM TO AGREEMENT FOR PROFESSIONAL SERVICES
BY AND BETWEEN

THIS SECOND ADDENDUM, made and entered into this _____ day of _____, 2020 effective on the 21st day of October, 2020, by and between the Village of Royal Palm Beach, Florida, a municipal corporation organized and existing in accordance with the laws of the State of Florida with offices located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, Florida 33411, hereinafter referred to as the “Village”, and Simmons and White, with mailing address at 2581 Metrocentre Boulevard Suite 3, West Palm Beach, Florida 33404, hereinafter referred to as “Consultant”, both of whom agree that the current “Agreement for Professional Services” regarding Traffic Calming Policy Development Services made and entered into by the Village and Consultant on the 21st day of October, 2016, is hereby amended in the following manner:

Section 1: The above-referenced Agreement regarding Traffic Calming Policy Development Services is extended to run from October 21, 2020 until October 20, 2022. This is the second and final extension of the term of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: All other Sections and recitals of the above-referenced Agreement and shall remain in full force and effect.

Section 3: This Addendum shall be attached to the current Agreement and shall become a part thereof.
