**FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL GRANT WRITING
SERVICES**

THIS FIRST ADDENDUM TO AGREEMENT FOR PROFESSIONAL GRANT WRITING SERVICES ("First Addendum") is hereby entered into this ____ day of January, 2021, effective retroactively as of April 10, 2020, by and between the Village of Royal Palm Beach, a municipal corporation, ("Village") having its principal office located at 1050 Royal Palm Beach Boulevard, Royal Palm Beach, Florida, 33411; and RMPK Funding, Inc., a Florida profit corporation having its principal address at 601 Heritage Drive #402, Jupiter, Florida, 33458 ("Consultant").

WHEREAS, the Village and Consultant entered into an Agreement for Professional Grant Writing Services ("Agreement") on April 10, 2018 with an initial term of two (2) years; and

WHEREAS, the Agreement provides that the Village has the option of extending the Agreement for two (2) additional two-year periods on the same terms and conditions, with such extension required to be in the form of a written amendment to the Agreement executed by both parties.

NOW, THEREFORE, and in consideration of mutual terms, conditions, promises, covenants and payments hereinafter set forth, the Village and Consultant agree as follows:

Section 1: The above-referenced Agreement for Professional Grant Writing Services is extended retroactively such that it shall run from April 10, 2020 until April 10, 2022. This is the first extension of the Agreement as permitted by the provisions of the Agreement at Article 1.

Section 2: All other Sections and recitals of the above-referenced Agreement shall remain in full force and effect.

Section 3: This First Addendum shall be attached to the current Agreement and shall become a part thereof.
