Agenda Item Summary

AGENDA ITEM:

Approval of the bid award in the amount of \$359,229.25 and authorization for the Village Manager to execute a contract with the lowest responsive, responsible bidder for the License Plate Reader Camera Installation (EN2106) project to ER Tech Systems Group Inc. dba Broadcast Systems.

BACKGROUND:

At the 2020 Strategic Planning meeting the License Plate Reader Cameras and Monitoring was ranked as a Top “12” Priorities for 2020 under Goal #3 Beautiful, Convenient Community. The project was then added to CIP with installation funding in 2020-21. The total approved project funding is \$460,000.

The project consists of the purchase and installation of license plate recognition (LPR) cameras. The cameras will be located at all major roadway entry and exit points in the Village. The cameras are to be configured to share data with the National Vehicle Location Service (NVLS) and shall be hosted by Vigilant Solutions.

ISSUE:

The Village solicited a request for bids on December 21, 2020. Two competitive proposals were received as outlined in the table below. Staff recommends awarding the contract to ER Tech Systems Group Inc. dba Broadcast Systems as they were the lowest responsive, responsible bidder, as allowed by Section 5.3.1 of the Bid Documents for License Plate Reader Camera Installation. Staff is not recommending use of the “lowest adjusted bid” provided for in Section 4.1.12 of the Bid Documents, to be used at the Village’s discretion, because of apparent insufficiencies regarding the time for project completion.
