Approval of bid award and authorization for the Village Manager to enter into an agreement with Aftermath Disaster Recovery, Inc. the lowest responsive, responsible bidder in the amount of \$690,550.00 for Debris Removal Services.

The Village desires to have a contractor in place to provide Debris Removal Services in the event of a major windstorm. The Contract is a unit price contract and the bid award is based on the estimated quantities provided on the Bid Proposal Form. The unit price for vegetative and construction/demolition debris is \$6.88 per cubic yard.
