Village of Royal Palm Beach Council Regular Meeting was called to order at 6:30 p.m. Thursday, May 16, 2019

The following action was taken:

- Awarded \$1,000 scholarships to ten high school seniors.
- Approved budget amendment to transfer \$20,000 from RV Boat Parking II to Customer Service Area.
- Approved addendum to extend Geotechnical & Environmental Engineering Services provided by Terracon Consultants for 2 years.
- Approved bid award to Custom Tree Care, Inc. for debris removal services in the amount of \$726,175.00.
- Approved first reading of Ordinance No. 887 Small Scale Future Land Use Map Amendment for First Baptist Church located at 10701 Okeechobee Blvd.
- Approved Architecture & Site Plan Modification amending landscape plan for Pioneer Estates.
- Approved Architecture & Site Plan Modification for existing Toyota dealership located at 9205 Southern Blvd.
- Approved Site Plan and Landscape Architecture for 11.20 acres on Southern Blvd. Properties-Lowes Road as well as a Landscape Waiver for 233 linear feet.
- Approved Parking Variance to allow tandem parking for multi-family residential property on Southern Blvd. Properties.
- Approved Development Agreement between RPB and Developer of Southern Blvd. Properties Pod 3.

- Approved Site Plan and Architecture for 318 multi-family residential development on Southern Blvd. Properties Pod 3.
- Adopted Ord. 990 in order to add minimum parking requirements for Private Recreational Facilities in Single and Multi-Family residential communities.
- Approved a 5-year contract for the Village Manager along with a 5% salary increase for initial year.
