

## Village of Royal Palm Beach Village Council Agenda Item Summary

Agenda Item:

PUBLIC HEARING TO CONSIDER VARIANCE APPLICATION 18-107 (VAR) AN APPLICATION BY URBAN DESIGN KILDAY STUDIOS AND APPROVAL OF VARIANCE ORDER VC 19-03, TO ALLOW A VARIANCE TO SECTION 26-80 (2) (B) TO PERMIT A MINIMUM LOT WIDTH OF 45 FEET WHERE THE VILLAGE CODE REQUIRES 55 FEET, FOR A 33.75± ACRE PARCEL OF LAND LOCATED ON THE SOUTH SIDE OF SOUTHERN BOULEVARD APPROXIMATELY 0.27 MILES WEST OF STATE ROAD 7. BY AGENT: KEN TUMA OF URBAN DESIGN KILDAY STUDIOS.

### Issue:

The applicant is requesting a variance from the Village's Code of Ordinances at Section 26-80 (2) (b) *Patio homes* in order to permit a minimum lot width of 45 feet where the Village Code requires a lot width of 55 feet within the Single Family Residential (RS-3) Zoning District. The Applicant through an accompanying application is requesting Site Plan Approval for 102 patio home (zero-lot line) single-family style units and the variance request is to allow the reduction in the required lot width for these units. These units are part of Pod 4 and for a location of Pod 4 please refer to Attachment A.

Village Code Sec. 26-32 (f) (6) allows the Village Council to grant variances to the Zoning Code when:

- a. That special conditions and circumstances exist which are peculiar to the land, structure or building involved, and which are not applicable to other lands, structures or buildings in the same zoning district;
- b. The special conditions and circumstances do not result from the actions of the applicant;
- c. That granting the variance requested will not confer on the applicant any special privilege that is denied by the zoning ordinance to other lands, buildings or structures in the same zoning district;
- d. That a literal interpretation of the provisions of this division would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of this division and would work unnecessary and undue hardship on the applicant;

- e. That the variance granted is the minimum variance that will make possible the reasonable use of the land, building or structure;
- f. The grant of the variance will be in harmony with the general intent and purpose of this division;
- g. Such variance will not be injurious to the area involved or otherwise be detrimental to the public welfare.

The Applicant contends that the proposed 3.02 units per acre is well below the allowed density for this zoning district and due to the encumbrance of the Florida Power and Light easement to the north there is a limited portion of the site area that can be used for development. The Applicant goes on to state within their Justification Statement that "This particular variance has been requested to be more in line with the patio home section of the code. The patio home section of the code allows lots to be a minimum of 40-feet wide in several other residential zoning districts. Although there are other residential districts that permit patio homes development at 40-ft, (RMU, RV-6, and RT-8) the Village specifically requested that the applicant propose RS-3 zoning for this pod and so they must follow the RS-3 zoning regulations. There are several neighborhoods in the Village that have lots with a 45-foot and 50 width, including the adjacent residential neighborhood (Victoria Groves)".

Village Staff is not in support of this variance because Staff believes that <u>no special</u> <u>conditions or circumstances exist which are not applicable to other lands</u>; the <u>condition</u> <u>is the result from actions of the applicant</u>; granting of the variance <u>will confer on the</u> <u>applicant special privileges that are denied to other lands</u>; the <u>literal interpretation of the</u> <u>Code does not deprive the applicant the rights enjoyed by other lands in the same</u> <u>zoning district</u>; and that it is <u>not the minimum variance necessary to allow reasonable</u> <u>use of the property</u>.



#### **ORDER APPROVING APPLICATION**

This cause came to be heard upon the above application and the Royal Palm Beach Village Council having considered the evidence presented by the applicant and other interested persons at a hearing called and properly noticed, and the Royal Palm Beach Village Council being otherwise advised.

**THEREUPON,** the Village Council of the Village of Royal Palm Beach finds as follows:

- The property which is the subject of said application is classified and zoned within the RS-3 Single-Family Residential District by the Zoning Code of the Village of Royal Palm Beach and the zoning map made a part thereof by reference.
- 2. The applicant is seeking a **Variance** from Royal Palm Beach Code of Ordinances at the following section: Section 26-80(2)(b) in order to allow a minimum lot width of 45 feet where the Village Code requires a lot width of 55 feet.
- 3. Under the provisions of Sec. 26-32(f)(6) of the Village Code of Ordinances, the Village Council has the right, power and authority to act upon the application herein made.
- 4. In the judgment of the Village Council, the public welfare will best be served by **APPROVING** the application as set forth on the application attached hereto as Exhibit B.
- 5. **IT IS THEREUPON CONSIDERED, ORDERED AND ADJUDGED** by the Royal Palm Beach Village Council as follows:

The application for **Variance**, **VC-19-03**, with reference to the abovereferenced property in the Village of Royal Palm Beach, Florida to permit a variance to Section 26-80(2)(b) in order to allow for minimum lot width of 45 feet in lieu of the 55 foot lot width is hereby **Approved** in accordance with the Village Code of Ordinances for the following reasons:

## The applicant meets the following standards set forth in Section 26-32 (f) (6). of the Village Code of Ordinances:

- 1. <u>Special conditions and circumstances exist;</u>
- 2. <u>Special circumstances are not the result of actions of the applicant;</u>
- 3. <u>No special privilege is conferred;</u>
- 4. <u>Literal interpretation would constitute an unnecessary and undue hardship;</u>
- 5. <u>This is minimum variance for reasonable use of land;</u>
- 6. <u>Is in harmony with the intent and purpose of this division; and:</u>
- 7. <u>Will not be injurious to area or detrimental to the public welfare.</u>

COMMENCING AT THE NORTHWEST CORNER OF SECTION 1, TOWNSHIP 44 SOUTH, RANGE 41 EAST, PALM BEACH COUNTY, FLORIDA; THENCE ALONG THE WEST LINE OF SAID SECTION 1, S01°50'01"W A DISTANCE OF 459.60 FEET; THENCE LEAVING SAID WESTERLY SECTION LINE, S59°20'02"E A DISTANCE OF 890.38 FEET TO THE NORTH LINE OF A 160 FOOT WIDE FLORIDA POWER AND LIGHT COMPANY EASEMENT AS RECORDED IN OFFICIAL RECORD BOOK 699, PAGE 534, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA; THENCE ALONG SAID NORTH LINE S88°57'45"E A DISTANCE OF 715.12 FEET TO THE POINT OF BEGINNING.
